President Lowell Johnson called the meeting to order at 6:00 P.M.

3. Consider and act on application from San Breth Hotels, LLC., requesting economic development incentives pursuant to the Chapter 380 Economic Development Program Policies and Procedures to construct and operate a hotel within the City of Corinth, Texas.

Jason Alexander presented the application to the Board. He shared that San Breth Hotels, LLC. proposes to design and construct a hotel having at least 93 rooms and 1,800 square feet of meeting space. Presently, San Breth Hotels, LLC estimates that their capital investment in the City will be at least is \$12,000,000.00. and that the hotel will create 45 jobs.

Wade May asked if San Breth Hotels, LLC. confirmed a site.

Alexander answered that they are looking potentially at developing the hotel at Millennium.

The Board had a general discussion about the fit of the proposed hotel at Millennium, and its economic impact on the community.

After the Board's general discussion, Alexander said that staff requests approval from the Board to begin formal negotiations with San Breth Hotels, LLC. Alexander said that if the Board approves staff's request, then staff would like to have an agreement for the Board to review and discuss at the next meeting.

Mike Amason asked if the Board should give staff some direction with respect to possible incentives.

Johnson said that the Board should go into closed session during the next meeting to give staff direction and discuss the specifics of a proposed agreement.

Johnson requested for staff to provide a copy of the agreement between the City of Denton and the Embassy Suites Hotel. He also requested for staff to obtain a copy of the business pro forma for the proposed Fairfield Inn.

MOTION was made by Blazewicz to allow staff to engage San Breth Hotels, LLC. in negotiations for economic development incentives pursuant to the Chapter 380 Economic Development Program Policies and Procedures to construct and operate a hotel within the City of Corinth, Texas.
