On this 1st day of August, 2016 the Corinth Economic Development Corporation (CEDC) of the City of Corinth, Texas, met in Regular Session at 6:00 P.M. at Corinth City Hall, located at 3300 Corinth Parkway, Corinth, Texas. The meeting date, time, place and purpose as required by Title 5, Subtitle A, Chapter 551, Subchapter C, Section 551.041, Government Code, with the following members, to wit:

CALL TO ORDER:

Vice President Mike Amason called the meeting to order at 6:01 P.M.

BUSINESS AGENDA:

1. Consider and act on minutes from the July 11, 2016 meeting.

MOTION CARRIES

2. Consider and act on the CEDC Finance Report for the period ending June 2016.

Jason Alexander directed the attention of the Board of Directors to the Hotel Occupancy Tax Collection Report for the month of June. The City experienced nine (9) percent increase in the occupancy rate and an increase of nearly \$13,000 for total gross sales. During that same period, the City collected nearly \$7,700 in taxes. There was a slight decrease in sales tax for June – the cash receipts were about \$56,230,

and the Budget anticipated \$59,669. Even with the decrease in the sales tax, it appears that the City will remain on target sales tax collection as projected in the Budget.

MOTION was made by Blazewicz to approve the CEDC Finance Report for the period ending June 2016.

MOTION CARRIES

3. Receive a presentation from Matthew Tate and Antoine Long with Buxton Company, on assisting the Economic Development Corporation in the implementation and execution of a retail recruitment and retention strategy.

Alexander introduced Matthew Tate and Antoine Long with Buxton Company. Alexander shared with the Board of Directors that Tate and Long are assisting staff with identifying and targeting potential retailers for Corinth and that their presentation tonight would focus on the methodology behind selecting retailers that would be an excellent match for Corinth's demographics, psychographics and vision for development and to provide a status report on four retailers currently engaged in deep discussions.

Tate then began the presentation with an overview of the City's and Buxton's shared goals to recruit and secure quality retailers. Tate then explained the methodology behind Buxton's process for identifying and targeting retailers with a selection history similar to Corinth. This methodology involves understanding consumer habits and preferences; establishing a trade area based on drive-time; and creating a unique "thumbprint" that distinguishes Corinth and its retail trade area from others. From there, Tate described, it is about narrowing the list of targeted retailers down to those that would be most interested in opening a unit in Corinth, and crafting and presenting a strategy based on the data-driven methodology to have quality conversations and sell them on Corinth.

The Board of Directors engaged Tate and Long in a general discussion that included questions about the drive-time (existing highway construction conditions versus future traffic improvements) and wanting to make a concerted effort to identify and recruit destination-oriented retailers.

Wade May inquired about Buxton's ability to further supplement their data-driven strategy to sell retailers on Corinth by sharing the City's vision for quality development. Alexander explained that Buxton provides data needed to initiate conversations with retailers from demographic and psychographic perspectives and that the vision is articulated by the City, resulting in a stronger sales pitch.

Tate spoke further on psychographics and developing a profile of consumers within a given trade area.

Long then presented the Board of Directors with a list of the targeted retailers first identified by Buxton as a match for Corinth as well as the retailers targeted for replacement because of the following factors: (i) no plans for immediate expansion into Texas; (ii) concerns about population and spacing; and (iii) a fear of potential cannibalization of existing units.

Amason recessed the Regular Session meeting at 7:02 P.M.

Amason reconvened the Regular Session meeting at 7:10 P.M.

Amason recessed the Regular Session meeting and went into Closed Session meeting at 7:11 P.M. (See Executive Session)

Mike Amason reconvened the Regular Session meeting at 8:37 P.M.

4. Board Members.

Burnett spoke briefly on the Birt Collins Organization. Burnett also encouraged the Board to read a recent article entitled the *You-Economy*. According to the article, one-third ($\frac{1}{3}$) of the households in the U.S. are currently participating in "You-Economy," and by 2020, this figure is expected to increase to nearly 50%.

Amason spoke on internet infrastructure. He shared that this may present an opportunity for the Economic Development Corporation to assist, support or possibly develop fiber optic lines in Corinth. This could present a situation where the City can lease fiber optic lines to generate additional revenues, which is similar to what other cities are doing.

Don Glockel asked, regarding the proposed "Millennium" project, if food trucks are a permitted use in the City. Alexander stated, as he understood it, they are not a permitted use. Food trucks would be a new use that would be added to the planned development.

Alexander briefly expounded on the discussion of food trucks. A suggestion was made to William Tsao, the lead developer of the proposed Millennium Development, to develop a restaurant park. This would create an environment where a row of restaurants could co-exist under one roof, rather than food trucks.

A brief discussion was held regarding food trucks and the selling of beer and wine in the City of Corinth.

5. Executive Director.



The tax is collected by businesses making the sale and is remitted to the State Comptroller of Public	The EDC sales tax revenue reflects a year-to-date increase in collections compared to the budgeted amounts.
Accounts on a monthly, and in some cases, a quarterly basis. Of the 8.25%, the state retains 6.25% and distributes 1% to the City of Corinth, .25% to the Street Maintenance Sales Tax Fund, .25% to the Crime Control & Prevention District, and .50% to the Economic Development Corporation. The State distributes tax proceeds to local entities within forty days following the period for which the tax is collected by businesses. 

AGENDA ITEM SUMMARY/BACKGROUND

Chapter 380 of the Texas Local Government Code, *Miscellaneous Provisions Relating to Municipal Planning and Development*, allows municipalities to establish and provide for the administration of one or more programs, including programs for making loans and grants of public money and providing personnel and services of the municipality, to promote state or local economic development. As it pertains to the City of Corinth, the purpose for proposing the Chapter 380 Economic Development Policies and Procedures (hereafter "Policies and Procedures") is to establish a clear set of guidelines and criteria for City Council and the Board of Directors of the Corinth Economic Development Corporation to consider and negotiate flexible incentive agreements to achieve and sustain the highest quality of development that will grow Corinth's tax base.

Staff is presenting the proposed Policies and Procedures to the Corinth Economic Development Corporation Board of Directors with the following goals: (i) to explain its intended applicability, advantages and implementation; (ii) to discuss eligibility requirements for projects; and (iii) to introduce pertinent factors that should be considered in the development and execution of any such incentives agreement.

After receiving direction from the Board of Directors during the September 12, 2016 Special Session, staff will make the necessary revisions to the Policies and Procedures for consideration and action at the October 3, 2016 Regular Session. Pending an affirmative response from the Board of Directors, staff will then take the proposed Policies and Procedures to the City Council in Workshop Session on November 3, 2016, with anticipated consideration and action taken by the City Council during their Regular Session on November 17, 2016.

AGENDA ITEM

Consider and act on the creation of sub-committees to advance the efforts of the Corinth Economic Development Corporation in: (i) developing a Strategic Plan for Economic Development; (ii) executing a Comprehensive Branding Strategy; and (iii) implementing a Business Retention Program.

AGENDA ITEM SUMMARY/BACKGROUND

Pursuant to Section 5.02, *Officers*, of the Bylaws of the Corinth Economic Development Corporation (the "Corporation"), the President of the Corporation is authorized to appoint sub-committees with the approval of the Board of Directors to advance the business undertakings of the Corporation. In addition, Section 4.07, *Sub-committees of the Board*, of the Bylaws allows the Board of Directors to designate no more than three directors to create (serve) on an official sub-committee. The sub-committees may only function as a recommending body, with the Board of Directors only, having the capability to exercise any official action of the Corporation.

As envisioned, the Board would designate three sub-committees, with each one charged with advancing one of the following efforts: (i) developing a Strategic Plan for Economic Development to guide the policy direction and actions of the Corporation; (ii) executing a Comprehensive Branding Strategy to re-brand Corinth and promote a positive image to the rest of the region and other organizations, entities and corporations with state and multi-national interests; and (iii) to implement a Business Retention Program that advocates for the various interests of existing business operators in Corinth.

Furthermore, and perhaps most importantly, the creation of the sub-committees will allow the Corporation (and the City) to develop a strong outreach program that allows residents and corporate citizens to act as change agents in influencing economic development policy and business development in Corinth.
